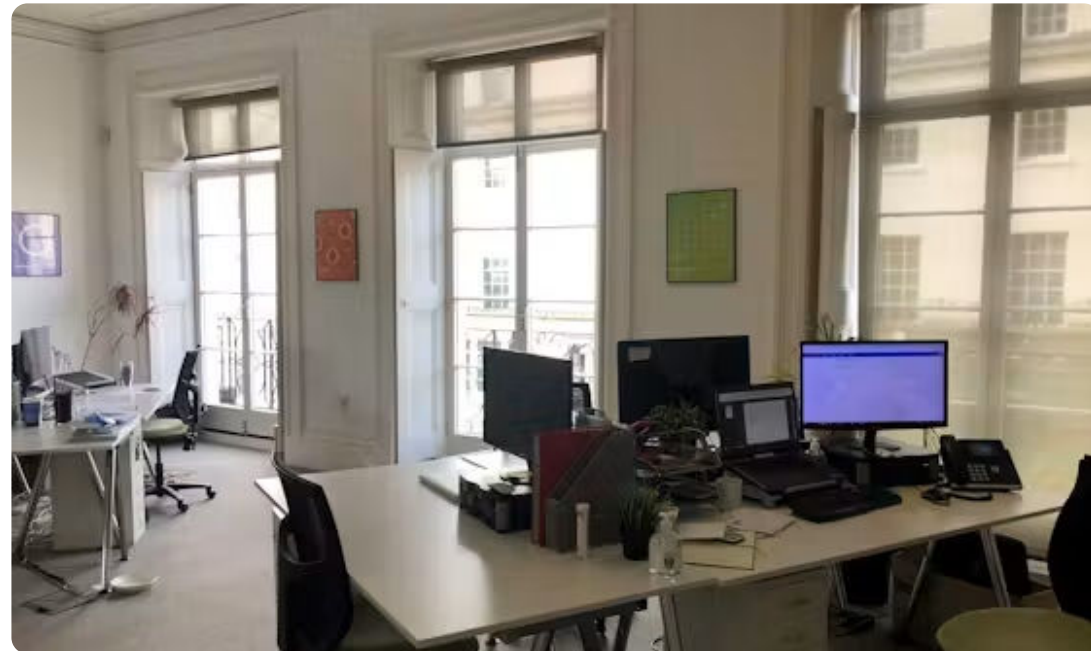
Description

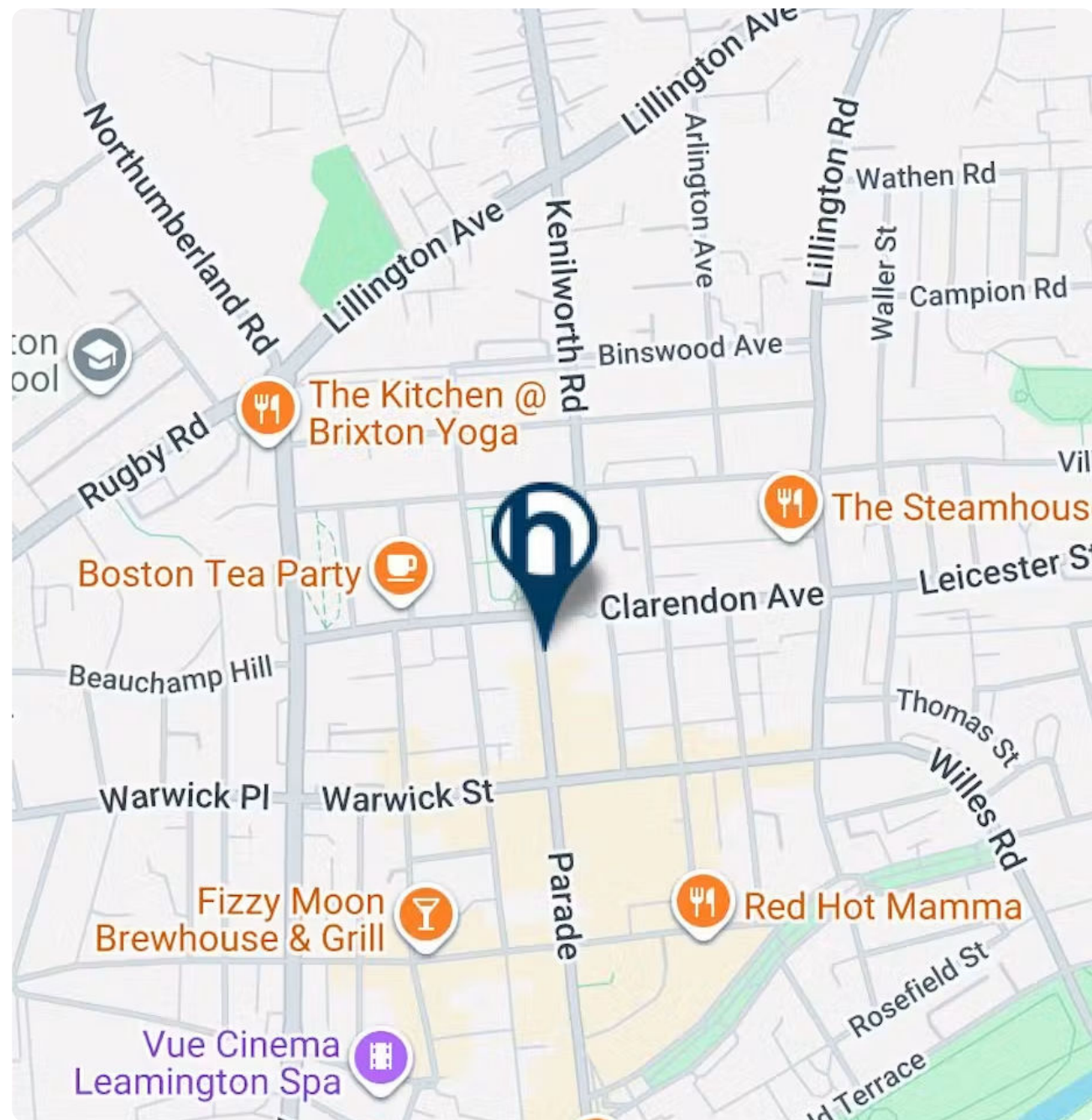

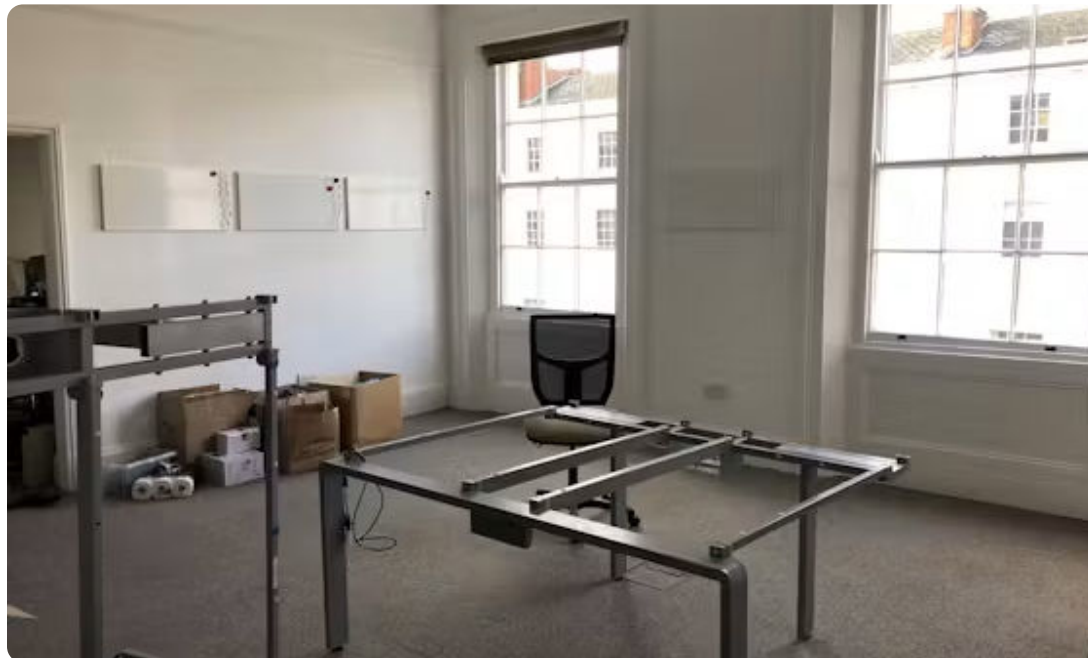
